### INTERPRETATION

In this Order:

- a) The expression "Order of 1985" means the London Borough of Hillingdon (Off Street Parking Places Order) 1985 as amended by the Variation and amendment Orders;
- b) The description "Ruislip Lido Willow Lawn Car Park" has the same meaning as set out within The Hillingdon (Off Street Parking Places) Order 1985 (Amendment No. 1) Order 2017.
- c) The description "Ruislip Lido Main Car Park" has the same meaning as set out within The Hillingdon (Off Street Parking Places) Order 1985 (Amendment No. 1) Order 2017.

# 3. AMENDMENT TO THE ORDER

The London Borough of Hillingdon (Off Street Parking Places) Order 1985 shall have effect as though the Schedules for "Ruislip Lido – Willow Lawn Car Park" and "Ruislip Lido - Main Car Park" were substituted by the Schedules as set out within this Order.


