Thank you for your e-mail dated 27 March 2019, inviting Highways England to comment on the above consultation.

Highways England has been appointed by the Secretary of State for Transport as strategic highway company under the provisions of the Infrastructure Act 2015 and is the highway authority, traffic authority and street authority for the strategic road network (SRN). The SRN is a critical national asset and, as such, Highways England works to ensure that it operates and is managed in the public interest, both in respect of current activities and needs, as well as in providing effective stewardship of its long-term operation and integrity. We will therefore be concerned with proposals that have the potential to impact the safe and efficient operation of the SRN.

Having examined the consultation document, we have no comments to make on the main modifications of the London Borough of Hillingdon's Local Plan Part 2. However, Highways England would like to affirm their willingness to work with Hillingdon in respect of future Local Plan development proposals that come forward. Highways England anticipate that robust Transport Assessments will come forward with significant development applications and any developments that could potentially impact the SRN will give appropriate consideration to the SRN within their assessments.
