1.1 The Revised Proposed Submission Version of the Local Plan Part 2, comprising the Development Management Policies, Site Allocations and Designations and Policies Map - Atlas of Changes, was published for comment on 26th October 2015. The Statement of Representation Procedure notes that the Council is only seeking comments on proposed changes to these documents, which are shown as either red text for additions or red strikethrough text for deletions.

1.2 This method of highlighting the changes does not lend itself well to the Policies Map - Atlas of Changes, which is comprised almost exclusively of maps and contains very little written text.
