# Tashan Daniel Award

# London Borough of Hillingdon Residents Services



# 1 Aim of the scheme

The council is launching a bursary award for young people in memory of Hillingdon resident Tashan Daniel, aged 20, who was tragically killed in an unprovoked attack at Hillingdon underground station in September 2019. Tashan was a keen sportsman with a passion to compete in the Olympic Games as a world class sprinter.

The Tashan Daniel Award supports young people to achieve their ambitions and aspirations. It also supports the growth of local talent. The bursary focuses on 3 distinct areas:

- Sport
- Culture
- Education

## 2 Eligibility

- 2.1 The scheme is open to any young person under the age of 21 years who is a Hillingdon resident.
- 2.2 The funding can only be used for travel, training or accommodation within the UK.

### 3 Budget

- 3.1 Bursaries will be capped at £2,000 per person, per annum.
- 3.2 The following use of funding will be considered:

#### Sport:

- training and competing opportunities
- equipment to enable training or competing
- accommodation and travel linked to training or competing opportunities

#### Culture (theatre, dance, crafts, literature, multidisciplinary arts, music, visual arts)

- relevant arts qualifications
- arts-related knowledge and skills development opportunities
- equipment to enable the above

#### Education

- vocational courses in further education, e.g hairdressing, mechanics
- travel costs, equipment and resources needed to complete the course

## 4 Application Procedure and decision making

- 4.1 There will be 1 funding round each year. Details will be announced on Hillingdon Council's website and through social media.
- 4.2 All applications must be submitted by the published closing date.
- 4.3 Applications must be submitted using the approved application form.

- 4.4. Applications must be signed by the individual, or if under 18 the parent/guardian.
- 4.5 Contact details of 2 people who can provide references must be provided to support the application.
- 4.6 Applications and supporting documents must be emailed to <a href="mailto:sportandphysicalactivity@hillingdon.gov.uk">sportandphysicalactivity@hillingdon.gov.uk</a>
- 4.7 Applications will be assessed by a panel and will be scored according to how well they meet set criteria. The panel will consist of: the Cabinet Member who holds the portfolio for the focus of the application, a council officer and a member of the Daniel family.
- 4.8 Applicants will be informed in writing of the outcome of the panel's decision within 2 weeks of the closing date for applications.
- 5 Conditions where bursary awards are made.
- 5.1 Bursary awards are conditional until 2 satisfactory references have been received.
- 5.2 Where opportunities are dependent on another source of funding, the council may make any grant conditional on the success of the other application.
- 5.3 If an application is successful, applicants agree to the following:
  - 5.3.1 Return the signed funding agreement plus any additional documentation before funding is released.
  - 5.3.2 Provide the nominated council offer with receipts, invoices, other proof of spend
  - 5.3.3 Inform the nominated council officer of any changes to personal circumstances that will result in the funding not being used as set out in the application.
  - 5.3.4 Promote their achievements as a result of receiving the bursary award through the council and the Tashan Daniel Campaign
