

Hillingdon at a glance, 2017

- Population comparing the 2011 Census figures with those with GLA Interim 2015-based population projections, the borough's population in 2017 has increased by approximately 10.9% (from 273,936 to 303,870); by comparison London's population has increased by 8.5%. Over half of Hillingdon's 44.6 square miles is a mosaic of countryside including canals, rivers, parks and woodland. Hillingdon has an average of 25.9 people per hectare; this is the third lowest population density among London boroughs.
- **Gender** 152,246 of borough residents are male and 151,624 are female.
- Age 21.7% of the borough population is under 16, 6.1% over 75 and 72.1% aged 16-74 (this is defined as working age).
- Ethnicity Hillingdon's White British population decreased from 73% in the 2001 Census to 52% in the 2011 Census; Hillingdon's BAME population increased from 27% to 48% in the same period. Current data (from the Greater London Authority 2015 Round Trend-based Ethnic Group Population Projections) shows that Hillingdon's White British population in 2017 is 43% and the BAME population is 57%.
- Religion¹ the predominant religions in the borough at 2011 are Christian 134,813 (49.2%), Muslim 29,065 (10.6%), Hindu 22,033 (8%) and Sikh 18,230 (6.7%), we also have a large percentage of residents stating 'no religion' 46,492 (17%) and other 23,303 (8.5%).


Barnhill Ward

Barnhill lies in the East of Hillingdon and is bordered by Charville, Yeading and Townfield, and partly by the London Borough of Ealing.

In 2017², Barnhill's population is 14,204 residents, an increase of 5.6% since 2011 (13,449); this is below the 10.9% increase for Hillingdon overall. Barnhill is made up of 211.9 hectares (2.1 km^{sq}), with 67 people per hectare (6,703 per km^{sq}). The average number of people per household in Barnhill is 3.1³.

Deprivation

The 2015 Indices of Multiple Deprivation (IMD) calculates local measures of deprivation and indicates where each small area is ranked in relation to the whole of England. The map below shows patterns of deprivation within Barnhill, which is made up of eight LSOA areas⁴.





Ward Population:



The chart above shows that 24.5% of Barnhill residents are under the age of 16. 70.8% of residents fall into the working age bracket (defined as a resident aged between 16 and 74) and the remaining 4.7% are over the age of 75.

The chart below shows that in Barnhill, there are higher numbers of males aged 40-44. However, the number of females is higher in the 35-39 age bracket compared to other age groups.




Gender

The proportion of men to women in the ward is 50.6% to 49.4%. This is a small change from 2011 when there was a 50.5% to 49.5% male to female ratio in the ward.

The chart below shows male/female ratios in Hillingdon and ward level:


Male/Female ratio at Hillingdon and ward level, 2017




Ethnic make up 2011⁵

In the 2011 census, 31.6% of Barnhill residents identified themselves as White British background (this includes English, Northern Irish, Scottish, Welsh, Irish, Gypsy or Irish Traveller and Other White). 3.7% from Mixed / Multiple Ethnic groups, 46.9% from Asian / Asian British background (including Indian, Pakistani, Bangladeshi and Chinese), 12.8% from Black / African / Caribbean / Black British backgrounds and 4.9% from other ethnic backgrounds (including Arab).

Hillingdon, Ethnic makeup 2011:





Religion⁶


Christianity is the predominant religion in the ward with 33.1% from this faith. 15.7% are Hindu, 16.1% Muslim, 19.2% Sikh with 9% having no religion. 5.4% chose not to state a religion (the question was voluntary). According to Census figures Barnhill has the highest number of residents stating their religion as Hinduism and the lowest number of residents in the Borough stating their religion as Christianity. Barnhill also has the lowest number in the Borough of residents with no religion.

Barnhill, Religion 2011:




Hillingdon, Religion 2011:

Country of Birth7

Of those living in Barnhill, 61.9% were **born** in Europe (with 54.6% in the UK), 26.8% in the Middle East / Asia, 9.4% in Africa, and 1.9% in the Americas, Caribbean or Australasia. In Barnhill 45.4% were **born** outside of the UK (with 54.6% in the UK).

Barnhill has the highest number of residents in the borough stating they were born in Sri Lanka (10.5% of all Barnhill non-UK born residents, 640); the ward has the second highest number of residents stating they were born in India (26.5% of all Barnhill non-UK born residents, 1,620).

The preferred **language** in Barnhill is English, with 66.3% of residents stating it as their main language; of the remaining 33.7%, the majority speak English 'very well' or 'well'. 868 residents (20.1% of those where English is not their main language) state that they cannot speak English well or at all⁸.

Apart from English the most spoken language in the ward is Panjabi with 10.4% (1,328), followed by Tamil with 5.2% (661). Barnhill has the highest number of residents speaking Tamil across the Borough.

In Barnhill, the working age population of those aged 16-24 make up 15.2%, whilst the 25-59 age group make up 71.5% followed by 13.4% from the 60-74 age group.



In Barnhill, 68.8% of residents of working age are economically active. The table below provides a breakdown of economic activity in the ward when compared with Hillingdon and England:



The chart below shows income deprivation being varied across Hillingdon. At ward level, the percentage of people who live in income deprived households ranges from 4.8% in Ickenham to 21.7% in Townfield. Barnhill is 18.3%, which is on the higher than the Hillingdon (13.6%) and England (14.6%).

Households

In 2017, there were 4,515 households¹⁰ in Barnhill; an increase of 84 since Census 2011. The majority of **housing type¹¹** within the ward is houses or bungalows (either detached, semi or terraced) at 73.6%, with 26.4% being flats or maisonettes (including those in a commercial building).



In Barnhill, 57.3% of ward residents are household owned, followed by 20.5% of properties being privately rented, 19.2% socially rented from the Council and the remaining residents make up 3% other e.g. shared ownership, living rent free.



Health

Life expectancy in the borough assesses the number of years a person is expected to live on average. In Barnhill, the life expectancy is estimated at 79.0 years for males and 82.3 years for females. This is similar to the averages for Hillingdon and England.




Observed Prevalence¹²

These graphs show the recorded prevalence of long term conditions from the Quality & Outcomes Framework (QOF) 2017/18, at GP practice level. They show the calculated prevalence of patients on a GP register, recorded as having a given condition. It should be noted that patients registered in this ward do not necessarily live in the ward or the Borough.

The graphs show recorded prevalence at England, London, borough, locality and ward level. Barnhill ward contains 2 GP surgeries (The Warren Practice and Yeading Court Surgery).

































The estimated prevalence is the number of patients who may have a condition but who have not been diagnosed.



Estimated prevalence is available on a limited number of conditions; data is taken from the latest Disease & Risk Factor Prevalence profile on Fingertips, 2015 (https://fingertips.phe.org.uk/profile/prevalence).

Barnhill ward contains 2 GP surgeries (The Warren Practice and Yeading Court Surgery). As before, patients registered with these GP practices do not necessarily live in the ward or borough.












