## **DATA PROTECTION PRIVACY NOTICE FOR Corporate Recovery Team**

### **Why are we providing this Notice to you**

The Council, in its capacity of Data Controller, holds certain information about you ("personal data") which it needs to process for the purpose of providing the following service of collecting and recovering debts due to the London Borough of Hillingdon. This Notice is designed to give you information about the personal data we hold about you, how we will use it, your rights in relation to it and the safeguards that are in place to protect it.

### **What personal data do we hold**

The types of data we hold and process will typically include:

The name, address and indirectly gender of a person with a sundry debt due to the London Borough of Hillingdon.

The names and contact details of their appointees or representatives including solicitors. Residents' financial records; bank account details; and documents for example income and expenditure forms, copy funeral invoices, bank statements and refund authority forms.

Records and invoices of a debt due including the source of that debt. National Insurance Numbers.

Employment details such as when recovering a debt by an attachment to earnings.

We may hold probate details in respect of debtors estates.

In respect of overpaid Housing Benefit we share some computer systems with the Housing Benefit team. The Housing Benefit team's privacy notice includes details of the type of information held on those systems.

Contact information including email addresses and telephone numbers.

We obtain most of this data directly from you and we may also obtain it from other sources. Sometimes we obtain data from other organisations including:

## **What is our purpose for processing your personal data**

This includes invoicing, collecting and recovery of sundry debts due to the London Borough of Hillingdon.

'if we intend to process your personal data for a purpose other than that for which the personal data was collected, we shall provide you details of that other purpose before we start processing your data'.

## **What is the legal basis for our use of your personal data**

- We need it to comply with a legal obligation
- We need it to perform a task in the public interest or in the exercise of official authority

## **What we do if your personal data is sensitive**

We will only process your sensitive personal data with your consent, unless we can lawfully process it for another reason permitted by law. We will notify you if it is sensitive and as with non-sensitive personal data, you have the right to withdraw your consent to processing at any time by letting us know. Sensitive data is data revealing racial or ethnic origin, political opinions, religious or philosophical beliefs, trade-union membership, genetic and biometric data, data concerning health or data concerning a natural persons sex life or sexual orientation.

## **For how long will we hold your personal data**

We will only keep your personal data for as long as we need to in order to fulfil the purpose[s] for which it is collected and for so long afterwards as we consider it may be required to deal with any questions or complaints about the service which we provide to you, unless we elect to retain your data for a longer period in order to comply with our legal and regulatory obligations.

## **Organisations that we may share your personal data with**

We may share your data with banks primarily in the collection of direct debits. Some of our invoices and documents are printed by an external printing company. We may share your data with courts.

We use an enforcement agency to collect certain debts.  
We may share your information with the Department of Work and Pensions.  
A company called Liberata provide a limited range of services for us.  
The Royal Mail delivers post for our service.  
Corvid Paygate in respect of some of our banking arrangements.  
We may share data with licensed insolvency practitioners.  
It may be shared with The Local Government and Social Care Ombudsman.  
We may share data with banks.  
We use external printers.  
We shares data with Her Majesty's Revenue and Customs  
The Clinical Commissioning Groups (NHS)

### **Internal Sharing of data**

We may share some of your data with other services within the London Borough of Hillingdon. Common examples include:

Adult Social Care

Legal

Financial Assessments

Benefits

Tenancy Services

The Client Financial Affairs team

Occasionally Council Tax

Youth Services

Each of these services (where required) has a privacy notice detailing the legal basis on which they processing the data.

### **Your rights**

You have a right to access and obtain a copy of the personal data that we hold about you and to ask us to correct your personal data if there are any errors or it is out of date. In some circumstances, you may also have a right to ask us to restrict processing of your data until any errors are corrected, to object to processing or to transfer or [in very limited circumstances] erase your personal data. If you wish to exercise any of these rights, please contact the Corporate Recovery Team (Contact details below). We may from time to time ask for further information from you. If you do not provide such information, or ask that the personal data we already hold is deleted or restricted, this may affect the service that we provide to you.
